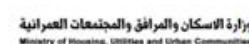

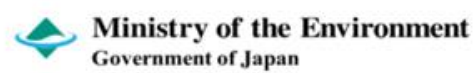

# Key Highlights of COP27

1. First COP in the global South since 2016, highest number of participations, technical, geopolitical, logistical challenges - one of the hardest COP
2. COP27 Cover Decision (Sharm El-Sheikh Implementation Plan – SHIP)
  - a. First-ever references to food, nature-based solutions, 4 references to renewable energy (0 in Glasgow) (inline with LGMA #MultilevelActionDelivers vision)
  - b. *highlighting the urgent need for multilevel and cooperative action* moved from preamble to para.51 (action by Non-Party Stakeholders)
  - c. none of the COP27 Presidency Initiatives (except early warning by UNSG) are recognized, but some including SURGe included in the COP27 Global Climate Action Outcomes, (Breakthrough Agenda on slide 13)
3. Loss and Damage Fund
  - a. first ever critical decision that is adopted at the same COP that was introduced in the agenda; and quickest to be delivered if 12-months calendar is implemented
  - b. Tectonic changes in alliances among Global North and South , leadership of Scotland in breaking taboos
  - c. Climate community intervening in the multilateral trade and banking system, following its impacts on energy, and technology
4. Global Goal on Adaptation (GLASS) – para-10.b – themes include cities, settlements and key infrastructure, as well as tangible cultural heritage
5. Art6.8 – list of new NMAs will be considered in future sessions – still possible to include *sustainable urbanization, including facilities like LoCAL*

# Key takeaways for LGMA from COP27

## 1. The GOOD

Climate action is now firmly based on two strong footing; with COP26 (Ambition) and COP27 (Climate Justice) conclusions, the successful delivery of the 2<sup>nd</sup> phase of the Paris Agreement depends on finance, governance and capacity building.

## 2. The ESSENTIAL

From Loss-and-Damage to SURGe, Urbanization Ministerial, Stocktake, Art6, ACE, Adaptation, NDCs and various national/supra-national initiatives, multilevel action, empowered by transformative impacts of sustainable urbanization is becoming the new normal for climate community at the national and global levels.

## 3. The INEVITABLE

The UNFCCC and COP engagement of stakeholders and decision making processes by Parties have to be aligned with the realities of the 21<sup>st</sup> Century and the spirit of the Paris Agreement.

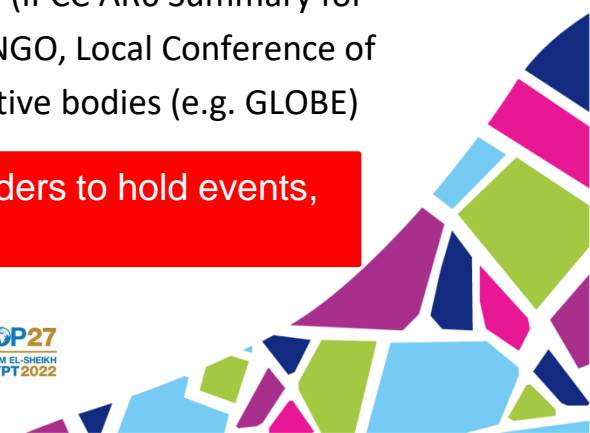

## Conflict of Interest at the UNFCCC

1. Process for enhancement of observer engagement by the UNFCCC Secretariat since August 2022 (poor attendance by LGMA)
2. Conflict of Interest as a major issue; 5 Constituencies push excluding fossil fuel lobby from COPs and/or a Declaration of Interest by COP27,
3. 5 Constituencies step out of the UNFCCC enhancement process on Col after COP27
4. Fossil fuel lobby at COP27; 600+ out of 49,000 (LGMA at COP27 was 500+), role of observers/Parties
5. Letter by 3 US Senators to UNSG and UNFCCC
6. LGMA Call at COP27 on 12 November for making the UNFCCC and COP process fit for 21<sup>st</sup> Century Paris Agreement Spirit
7. Next steps; continuation of UNFCCC Constituency consultations on administrative measures, potential agenda and initial steps by the UNFCCC Secretariat at SB58, additional efforts by 5 Constituencies



## Sept 2022 Proposal by 5 Constituencies for UNFCCC Representatives of non-governmental organizations Declaration of Investment, Interest, or Affiliation with GHG Emissions-Intensive Industries, Entities, Products

**GHG Emissions-Intensive Industries, Entities, or Products (EIIEP)** are defined as those which inherently drive the use and expansion of GHG emissions-intensive products and are therefore in direct contravention of the mandates of the UNFCCC and any protocol or agreement adopted thereunder. These include but are not limited to the fossil fuel, coal, petroleum, natural gas, petrochemical, big forestry and agribusiness industries, amongst others.

**Interest** is defined as receiving any direct or indirect financial or non-financial contributions, benefits, favours or funding, including gifts and services, monetary or in-kind, from any entity or individual affiliated directly or indirectly with EIIEP in the past ten years.

**Affiliation** is defined as professional or personal relationship with, partnership with, or employment by, EIIEP, including but not limited to membership group, trade associations, or initiatives legally, financially, or otherwise beholden to advance the interests of EIIEP, in the past ten years.

**P.S. BY LGMA FOCAL POINT:** The current proposal does not include LGMA, but it is highly that this may apply to LGMA as well. And it is highly likely that a strict interpretation of the above definitions may lead to exclusion of any LGMA delegation.

- I declare that I and/or the organization(s) which I am representing do/does not have any interests in, or receive any direct or indirect financial or non-financial contributions, benefits, favours or funding, including gifts and services, monetary or in-kind, from any organization, entity or individual affiliated directly or indirectly with EIIEP (as defined in the terms), in the past ten years
- I declare that I am not affiliated with and have not been employed by nor partnered with or associated entities in GHG-emissions intensive sectors (as defined by EIIEP in the terms) with the aim of driving the use and expansion of emissions-intensive products, including but not limited to coal, petroleum, natural gas, and petrochemicals, in the past ten years.
- I declare that I and/or the organization(s) which I am representing am/is not affiliated with, have interests in, or do not have a professional relationship with industries or associated entities working to advance the interests of GHG-emissions intensive products and activities across the coal, petroleum and natural gas sectors, in the past ten years.  
NOTE FROM FCTC: the notion of “professional relationship” used here is to be understood as not including a public office holder’s interactions with the fossil fuel industry required for setting and implementing environmental and climate policies which reduce dependence on fossil fuels).
- I declare that the above information is true to the best of my knowledge and that non compliance with this form, as defined in the terms, may result in the withdrawal of the organization I represent .
- I understand that for the purposes of transparency, the information on this form will be made publicly available for a minimum of five years.

## Key achievements for subnational governments and cities at Biodiversity COP15 - pending for final decisions by 19 December

1. Post-2020 Global Biodiversity Framework (yet to be adopted by CBD COP15)
  - **Target-12:** *Significantly increase the area and quality and connectivity of, access to, and benefits from green and blue spaces in urban and densely populated areas sustainably, by mainstreaming the conservation and sustainable use of biodiversity, and ensure biodiversity-inclusive urban planning, enhancing native biodiversity, ecological connectivity and integrity, and improving human health and well-being and connection to nature and contributing to inclusive and sustainable urbanization and the provision of ecosystem functions and services.*
2. 2<sup>nd</sup> 10 Year Action Plan - Conference Room Paper No.9 By CBD COP15 Working Group-1 (no brackets)
