The intern (for a mandatory internship) will support the Circular Development Team in delivering on project objectives and deliverables.

Intern – Nature-based Solutions, Circular Development Team

The position is open to eligible and qualified Master's students who must complete a mandatory internship as part of their studies.

An internship with ICLEI offers the opportunity to acquire direct practical experience on sustainability knowledge under the supervision of experienced staff. Internships are offered depending on the availability of meaningful assignments as well as the needs and capacity of the team to receive and supervise interns. Interns will be a part of the international ICLEI World Secretariat team based in Bonn, Germany and will be placed within the Circular Development Team.

Tasks may include:

Assist the implementation of the H2020-funded CLEVER Cities project and particularly the UrbanByNature capacity-building activities in China, South America and South Eastern Europe:

- Support with overall project management and coordination tasks such as following up with ICLEI regional offices and partners on the delivery of tasks
- Support the preparation and execution of webinars such as liaising with speakers', compiling webinar agendas, taking notes during the webinars
- Support the development of communication assets such as web content and newsletter contributions
- Support the organization of workshops focusing on event logistics (incl. payments and reimbursements), agenda development and speakers' management

Main requirements:

Formal essential requirements:

- Being enrolled in a vocational training or university in a relevant subject, such as urban planning, environmental science, public policy, or similar.

Professional requirements and behavioral competences:

- Excellent communication skills and command of English (speaking, writing, reading). Additional language skills are an asset.
- Coherent and concise writing skills.
- Strong organizational skills.
- Confident user of Microsoft Office and particularly competent in MS Excel.
- Positive, flexible, and pro-active work attitude.

Advantageous competencies:

- Additional language skills are an asset (particularly Chinese, Spanish and Portuguese).
- Previous (academic and/or professional) experience in the field of nature-based solutions for urban regeneration



Terms and conditions:

- ICLEI is offering a monthly compensation of EUR 880 gross (brutto) for the full-time internship.
- The position is available for a minimum three months to a maximum of six months.
- Possible start date: First half of January 2022.
- The intern will be supervised by ICLEI's Transitions Concept Officer.
- Working hours: 40 p/week, 2,5 days of leave per full month.
- Working language: English.
- Contract will be based on German law.

- Indication of citizenship; if non-EU, whether applicant is holder of a **work permit** for Germany (i.e. do you have a work permit from the German government that allows you to work as an intern during your studies?)
- **Insurance:** Do you have a German health insurance (including pension insurance number) that could also be used for your internship?
- **Indicate** whether conducting an internship is a **mandatory** component of your curriculum to be able to graduate
- Indication of possible **start date**
- Indication of envisaged **duration of internship**, minimum of 3 to maximum of 6 months
- **Equipment:** indicate whether you have a laptop and access to the internet when working remotely
- **Location:** Where are you staying at the moment? This is particularly important to ensure the intern and the supervisor can have a minimum number of in-person meetings at ICLEI premises in Bonn.
